- We have grown to 733 meetup members and 81 contributing artists.
- The paintout with critique program was once again a smashing success. Thanks to Manny for coordinating this. Overall, there were 11 paint-outs at 11 locations with 4 new locations this season. The average number of artists per paint-out was 33.
- We are developing a collector base for our contributing artists'. This season between Plein Fun Fest and exhibits; Boca Raton Historical Society, Art on the Square & Ocean Ridge we were able to pay artists' a total of over \$7000.

**** New Process for CA Donation ****

We have heard back from many of our CA's (Contributing Artists') that the system of announcing that CA donations are due sometimes get lost in the shuffle. We really appreciate all the support and we want to make that process easier. Beginning next season, the treasurer will send individual pledges by email to current CA's for 2019 renewal. The pledge requests will come out on November 1^{st} , 2018 and will be due January 1^{st} , 2019. The pledge request will allow you to 'click to pay'. Artists' who wish to become a CA for the first time will still make the initial donation through the PayPal link on the website. That will get the artist into our CA database. Also effective in 2019 the minimal CA donation will be \$35.
